The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest-bearing instruments.

Market Review

The FBM KLCI inched up 1.3% in August due to foreign buying and window-dressing activities. In the recent 2Q2022 results season, misses to beats ratio has narrowed with banks sector emerging as the biggest winner as most banks reported results that were in-line or above expectations underpinned by strong loan growth and better net interest margins. Election rumours continue to swirl and dominate news flow. On a year-to-date basis, KLCI slipped by 3.5%.

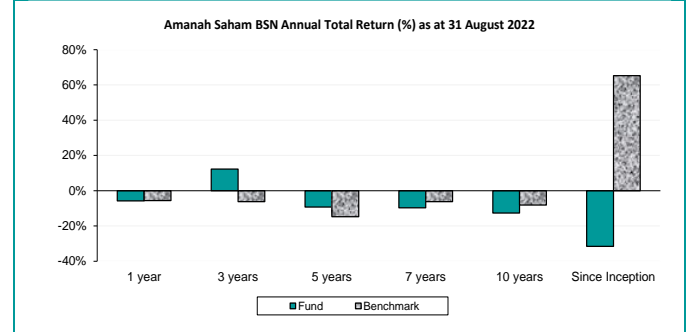

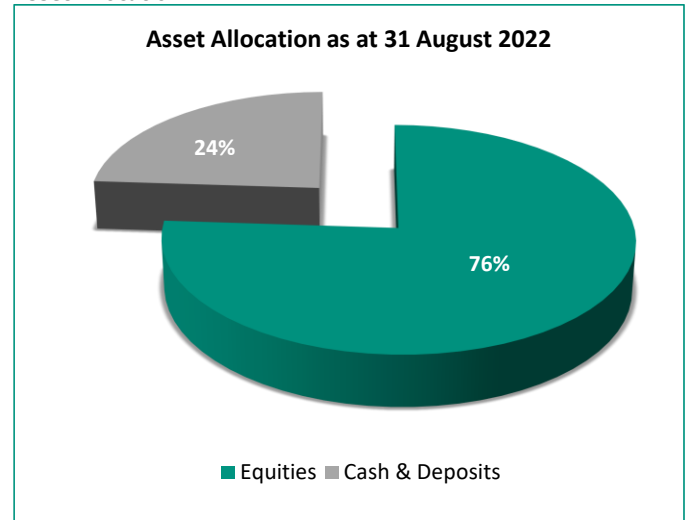
