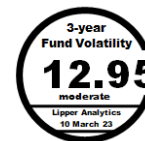




AMANAH SAHAM BANK SIMPANAN NASIONAL (ASBSN)



Fund Objective

The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest-bearing instruments.

Market Review

The FBM KLCI declined 2.11% in February, with the best performing sectors were Transportations, Energy, Properties and Constructions. Concerns over increasing inflation in the US pushed investors to be more cautious in February. The neutral Budget 2023 also did not have the positive push factor to the domestic market. The recent 4Q22 corporate results announcement were generally neutral, where misses-to-beats ratio were balanced as there were lower earnings disappointments on a quarter-on-quarter basis.

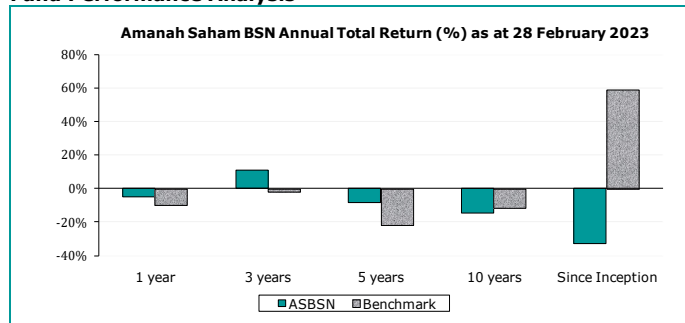

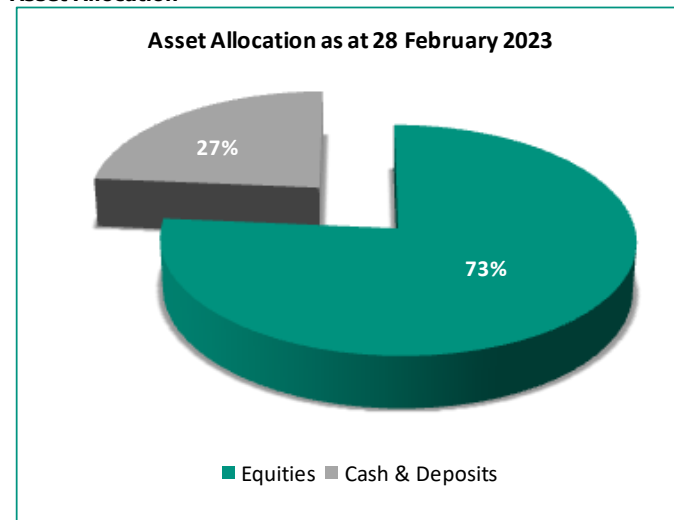
