## Fund Objective

The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest bearing instruments.

## Market Review

FBM KLCI and FBM Shariah Index declined 3.2% and 4.7% respectively in June. Meanwhile, the FBM Small Cap Index dropped 3.6% in June. A total lockdown came into effect in June due to the surge in COVID-19 cases. The government announced the PEMULIH economic recovery package amounting to RM150 billion or around 10% of GDP, which encompasses a 6-month blanket loan moratorium, cash assistance, food aid, EPF withdrawal scheme (i-Citra), electricity discounts, amongst the many initiatives. The government also unveiled its National Recovery Plan comprised of a four phase exit strategy from the current Phase 1 lockdown. World Bank revised Malaysia's 2021 GDP forecast down to 4.5% from 6.0% earlier amid a dramatic resurgence of COVID-19 infections. Foreign investors were net sellers of RM1.2 billion in June 2021, taking year-to-date net selling to RM4.2 billion. Brent crude oil rose 8.4% to USD75.1 per barrel while CPO declined 8.2% to RM3,599 per ton. Ringgit fell 0.6% MoM to 4.15 against USD in June.

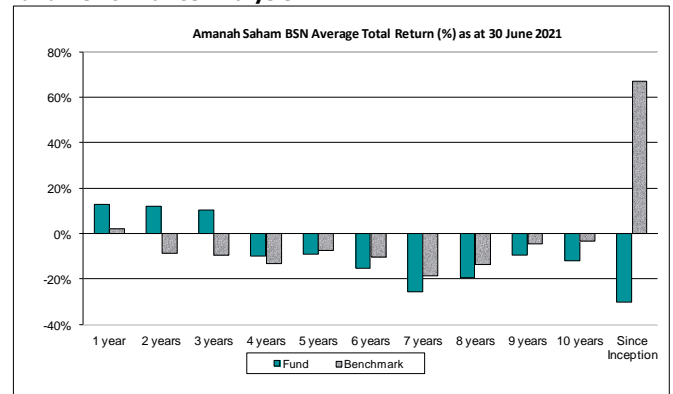
