Market Review

The FBMSHA inched up 0.7% in August due to foreign buying and window-dressing activities. In the recent 2Q2022 results season, misses to beats ratio has narrowed with banks sector emerging as the biggest winner as most banks reported results that were in-line or above expectations underpinned by strong loan growth and better net interest margins. Election rumours continue to swirl and dominate news flow. On a year-to-date basis, FBMSHA dropped 11.8%.

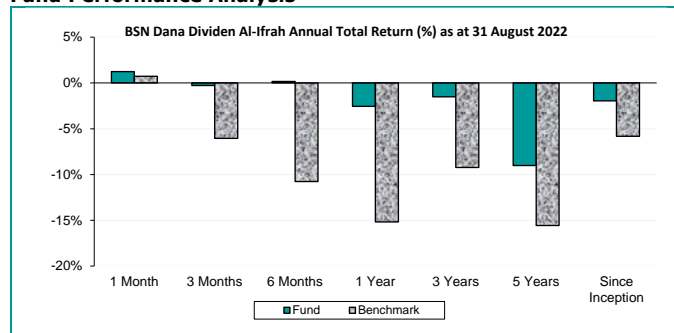

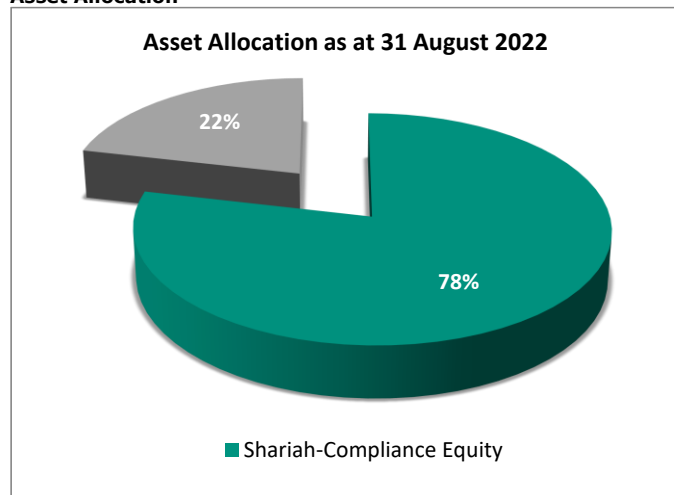
