Market Review

FBM Shariah finally changed its course, recording a 4.74% increase in February to 12,118 points. This could be attributed to the Russia-Ukraine conflict posing minimal direct impact to Malaysia, although the indirect impact could come from weaker export demand, particularly from European countries and regional countries involved in the global supply chain of the semiconductor industry. The fourth quarter GDP rebounded to expansion of 3.6% as the economy re-opens and recovers post-lockdown.

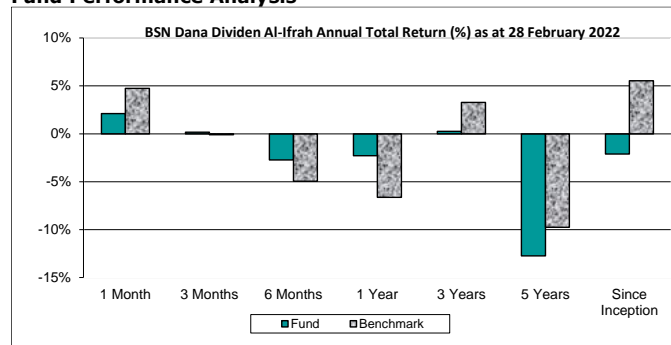

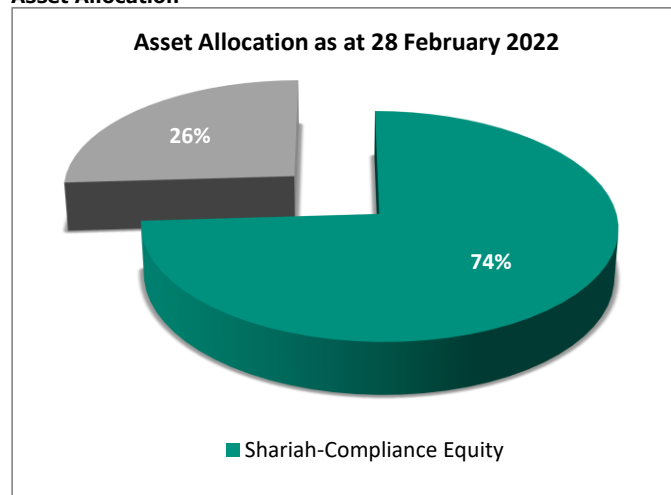
