Fund Objective

The Fund seeks to provide consistent income* by investing in Shariah-compliant equities with attractive dividend** yield and/or potential dividend yield.

*Note: Distribution of income will be done by way of reinvestment into additional Units.
**Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

Market Review

In the month of June, FBMKLCI was up by 1.9% and FBM Syariah rose 0.1%. Economic Recovery Plan (PENJANA) was unveiled by the Prime Minister on 5 June which contains 40 measures worth MYR35b, mainly focusing on jobs initiatives, supports for micro, small and mid-enterprises, stimulating consumption and Foreign Direct Investments, and facilitating digitalization. According to the Ministry of Finance, Malaysia's 2020 budget deficit/GDP is now expected at 5.8%-6.0% on PENJANA's MYR18b direct fiscal impact vs previous 4.7%-5.0% due to Economic Stimulus Package (PRIHATIN). Also, there was further easing of the Movement Control Order, allowing most activities including domestic tourism to resume on June 10. Ringgit strengthened by 1.4% to RM4.29 against USD. On the commodities front, WTI and Brent futures rose 11.8% and 9.0% respectively while gold gained 3.0%.

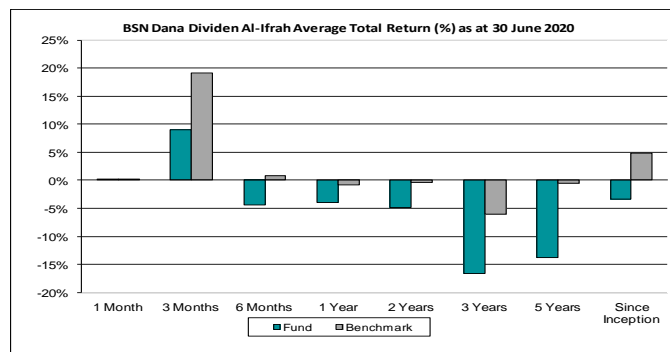
