## Fund Objective

The Fund seeks to provide consistent income\* by investing in Shariah-compliant equities with attractive dividend\*\* yield and/or potential dividend yield.

\*Note: Distribution of income will be done by way of reinvestment into additional Units.

\*\*Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

## Market Review

FBM KLCI and FBM Shariah Index ended the month marginally lower at -0.3% and -1.0% respectively from the extension of Conditional Movement Control Order locally and political instability towards later part of March. Sectors with positive returns were property, construction, transportation, industrials and telecommunications; while technology, healthcare and plantation sectors posted negative returns. CPO retreated by 3.47% to RM3,612 and crude oil fell 3.92% to end at USD63.5 per barrel as fresh lockdowns in Europe stoked fuel consumption fears and a pessimistic demand outlook from OPEC and its allies. Retailers remained as net buyers at RM1.6bn (vs RM2.0bn in February) whilst local institutions were net sellers at RM1.6bn. Foreign institutions remained net sellers at RM34m. Ringgit was weaker by 2.35% to RM4.15 against USD at the end of March 2021.

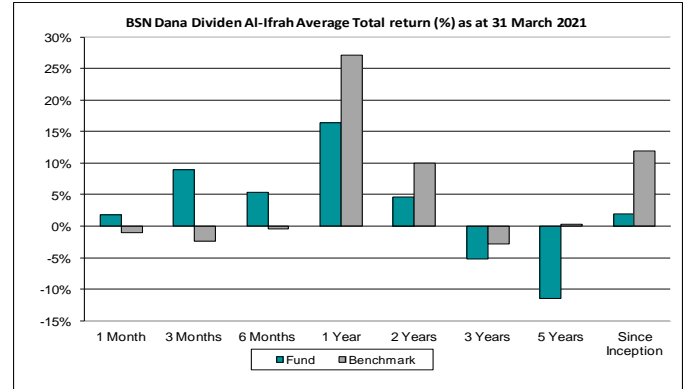
