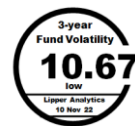




BSN DANA DIVIDEN AL-IFRAH



Fund Objective

The Fund seeks to provide consistent income* by investing in Shariah-compliant equities with attractive dividend** yield and/or potential dividend yield.

*Note: Distribution of income will be done by way of reinvestment into additional Units.
 **Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

Market Review

The FBM EMAS Shariah Index grew 4.0% in October due to pre-election rally following the dissolution of parliament on 10 October and a return of interest in glove players. Foreign investors were significant net sellers at the beginning of the month but turned net buyers in the last week of October. Glove sectors were among the biggest gainers in October as investors accumulated glove makers following the recent sharp sell down. The best-performing sectors in October were healthcare, transport, and plantation. On a year-to-date basis, FBMSHA dropped 15.1%.

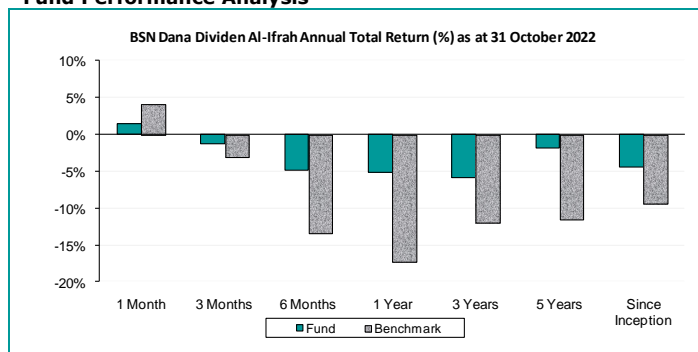

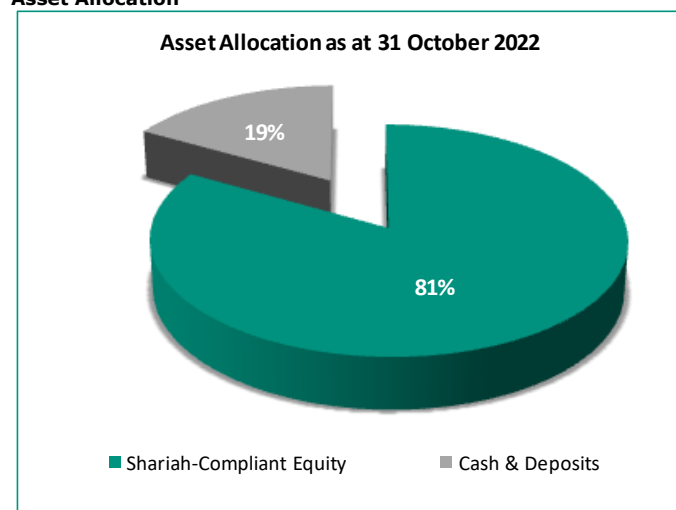
