Market Review

The FBM EMAS Shariah Index dropped 7.4% in September to 10,008.03 points dragged down by the turmoil in global markets and foreign selling. Election rumours continue to swirl and dominate news flow during the month. The markets were holding their breath for the tabling of Budget 2023 which will be held on 5th November. On a year-to-date basis, FBMSHA dropped 18.4%.

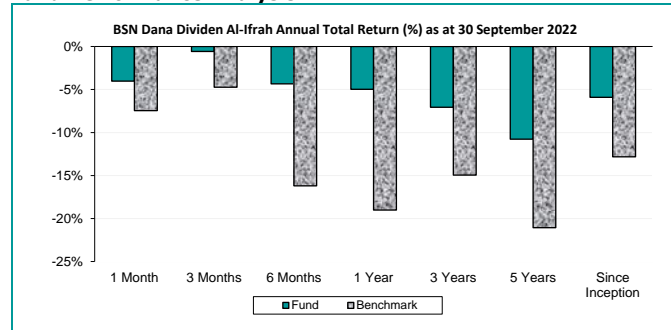

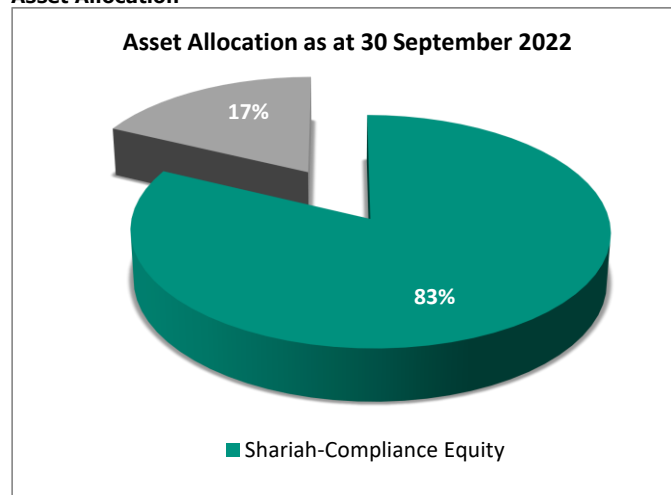
