Any material change to the investment objective of the Fund would require the Unit Holders' approval.

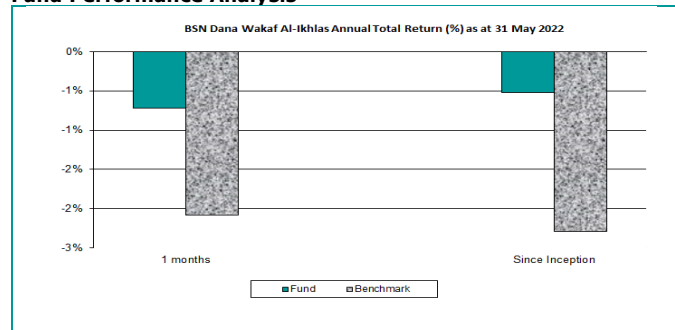
Market Review

The FBM EMAS Shariah Index dropped 4.3% in May as the equity market react to Federal Reserve and subsequently Bank Negara tightening their monetary policy during the month. Window dressing activities on the last 5-trading days did not manage to recover the loss on the first half of the month. During this round of result season, out of 30 KLCI components, only 8 results were above expectation while the rest were below expectation, further underwhelming the market sentiment. Domestic market sentiment remains weak as investors remain on the sideline pending further domestic catalyst. On a year-to-date basis, FBMSHA dropped 6.1%.

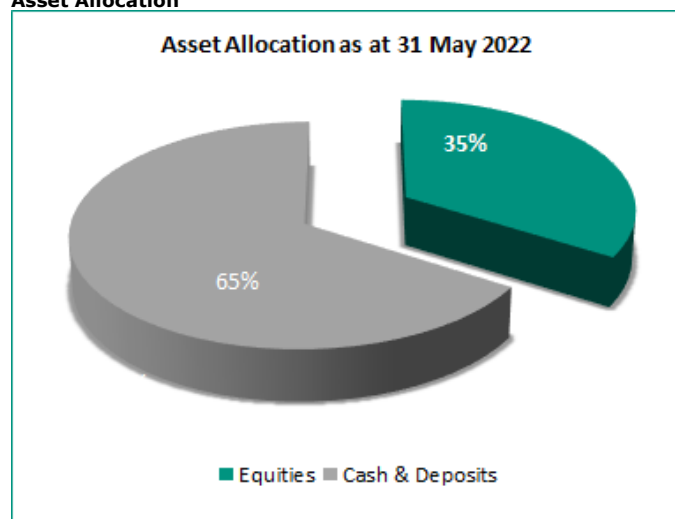
