### NOTES & CONDITIONS : PERSONAL DATA PROTECTION DATA ACT 2010

#### PERSONAL DATA PROTECTION DATA ACT 2010 (Notice Pursuant to Section 7)

The Personal Data Protection Act 2010 (hereinafter referred to as the "Act"), which regulates the processing of personal data in commercial transactions, applies to Permodalan BSN Berhad (hereinafter referred to as "PBSNB", "our", "us" or "we").   - g. To provide services;
  - h. To research, develop and improve our events, programs, products and services; and
  - i. For any other purpose that is incidental or ancillary or in furtherance to the above purposes.
