Fund Objective

The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest-bearing instruments.

Market Review

Despite our relatively better tariff compares to major ASEAN peers, FBMKLCI posted a -6.7% return in 1H2025 making it one of the worst performing markets, second only to Thailand. REITS was the only sector recording positive returns in 1H2025, gaining 3.6%. The worst performing sectors during the period were Healthcare, Technology and Industrial, losing 28.3%, 21.4% and 12.8% respectively.


