The investment objectives of ASBSN are to seek medium to long term capital appreciation of the Units through investment in the equity markets and to seek income opportunities by investing in high income yielding securities and interest-bearing instruments.

Market Review

FBMKLCI posted 12.9% return in FY2024 in line with the global market, pushed by the Utilities sector. The local mid cap stocks outperformed the large caps, as both the FBM70 and FBMSHA recorded gains of 28.9% and 14.6% respectively. Construction was the best performing sector, gaining 60.7% during the year, while Telco was the worst performing sector, losing 4.4% during the year.

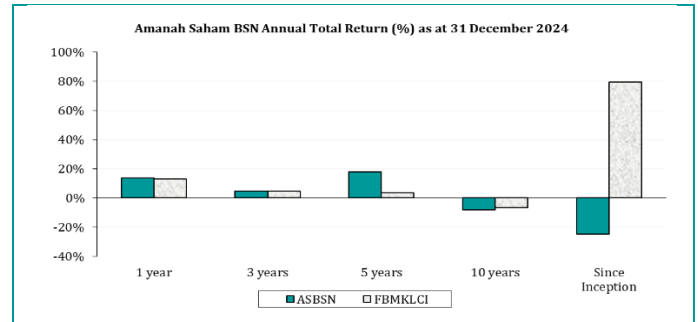

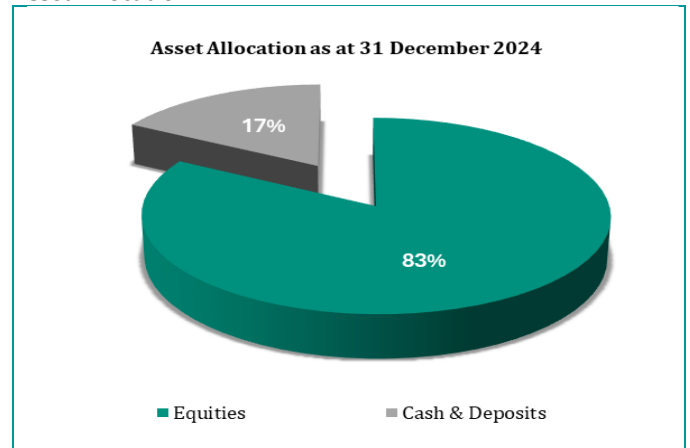
