Fund Objective

**Note: "Attractive dividend" refers to stocks of companies which have provided an average gross dividend of at least 3% for the past 3 years from the latest financial year.

Market Review

The FBM EMAS Shariah Index declined 0.3% month-on-month in October 2023 and declined 0.9% year-to-date. Finance and Construction were the best performing sectors for the month, gaining 2.1% and 0.9% respectively. Foreign investors were net sellers of RM2.2 billion worth of equities during the month, bringing year-to-date net selling to RM4.2 billion.

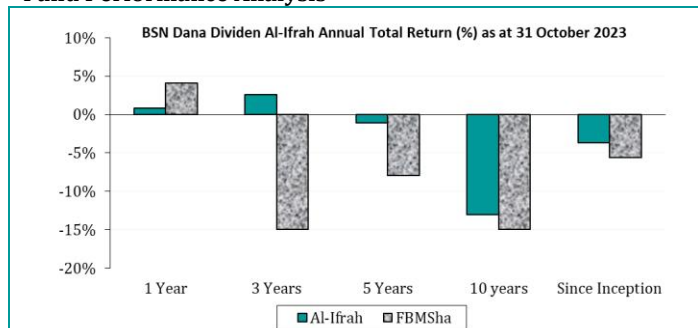

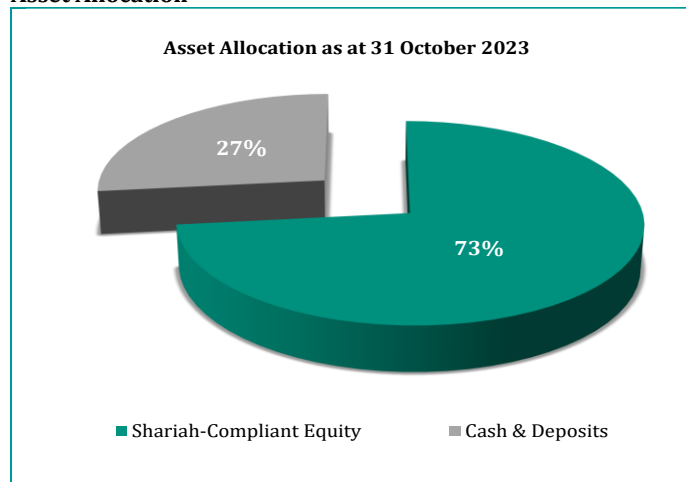
