## Market Review

In April 2026, Malaysia's Government Investment Issues (GII) yields fell by 3 to 9 basis points, supported by both domestic and foreign demands. Foreign fund flows remained positive, recording net inflows of RM3.8 billion (Mar: RM6.1 billion), bringing YTD net inflows to RM8.4 billion. Furthermore, the 10Y UST yield jumped to 4.4% at end of April (Mar: 4.3%), as market continued to reassess Fed's policy outlook following its hawkish pause, elevated inflation expectation and uncertainty stemming from Middle East developments.

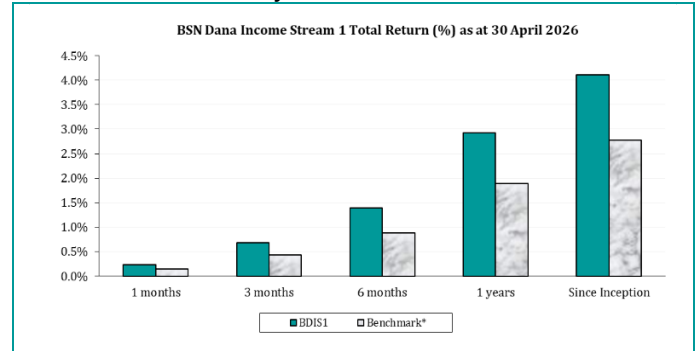

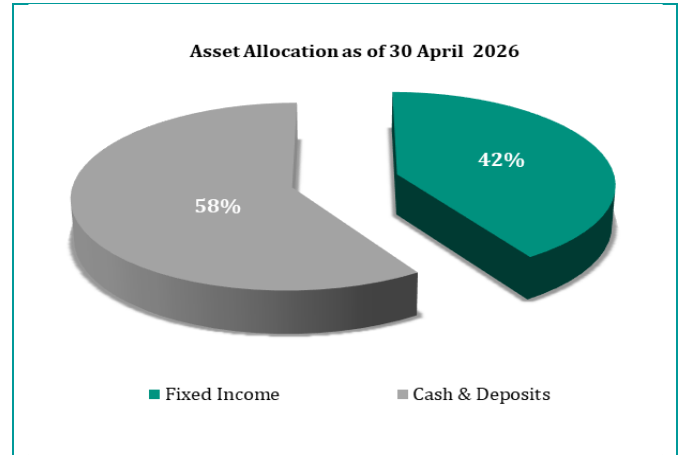
