Market Review

In July 2026, Malaysia's Government Investment Issues (GII) yields edged higher by 6 to 12 basis points, in line with global yields movements. Foreign investors turned net sellers, recording net outflows of RM5.6 billion (June: RM4.9 billion net inflow), bringing YTD net inflows to RM3.4 billion. Furthermore, the 10Y UST yield rose to 4.75% at end of July (June: 4.44%) as escalating tensions in the Middle East heightened concerns over supply disruptions, pushing oil prices higher and raising concerns over inflation.

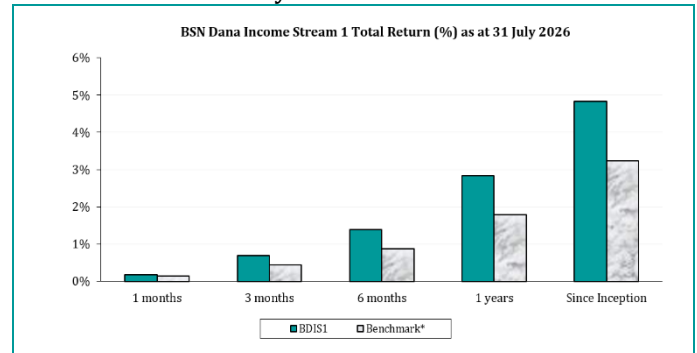

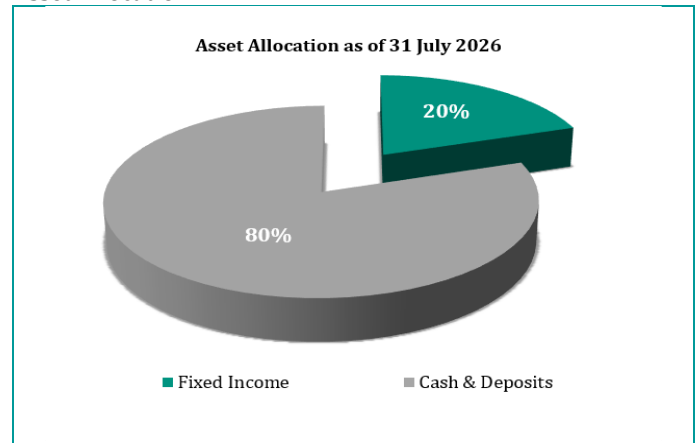
