## Market Review

In May 2026, Malaysia's Government Investment Issues (GII) yields rose by 1 to 4 basis points, driven by persistent geopolitical uncertainties and elevated oil prices. Foreign investors sentiment turned cautious, resulting in net outflows of RM4.3 billion. However YTD remained positive at RM4.12 billion. Furthermore, the 10Y UST yield increased to 4.45% at end of May (Apr: 4.40%), as market continued to price out rate cuts and increasingly priced in the possibility of a rate hike before the end of 2026.

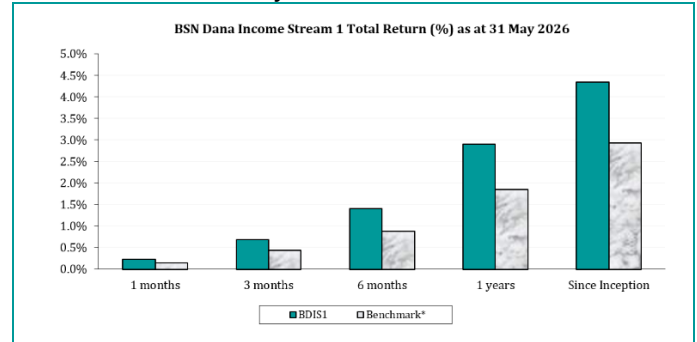

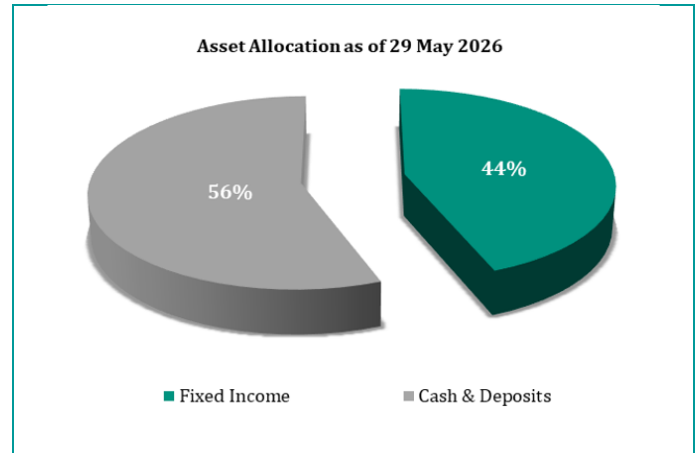
